## **SPECIFICATIONS FOR: SUPPLY OF DSTV MULTI SWITCHES AND WATERPROOF ENCLOSURE FOR HOUSING COMPANY TSHWANE.**

### **1. Purpose**

The purpose of this Request for Quotation (RFQ) is to invite bidders to submit quotations for the supply of DSTV multi-switches and waterproof enclosures for the Townlands Development phase 1.

### **2. Introduction**

Townlands Development Phase 1 comprises 691 residential units. The installation of DSTV infrastructure commenced after the completion of construction, following the occupancy of tenants in December 2022. No prior provision had been made for the installation of DSTV during the design and subsequently construction phase. Consequently, DSTV multi-switches were installed beneath the electrical distribution boards on each floor. During the rainy season, multiple DSTV switches in various blocks sustained water damage.

Notably, tenants residing in Block R, Ground Floor, reported signal disruptions. Upon investigation, it was determined that water ingress had compromised the functionality of the DSTV switches. Further inspections revealed similar concerns in several other blocks within Phase 1.

To prevent recurring damage and ensure the long-term safety and operability of the DSTV infrastructure, proactive measures must be undertaken, by providing for waterproof enclosures for the areas where the DSTV switches have been installed. And as a remedial action, replace the damaged DSTV switches.



### **3. Objective**

The objective of this report is to identify issues related to water damage which affected DSTV multi-switches and to propose a solution to mitigate future damage. The installation of waterproof enclosures will minimize damage, extend the lifespan of the multi-switches, and reduce replacement costs. By implementing these protective measures, this report seeks to enhance the reliability and longevity of the DSTV infrastructure within Townlands Development Phase 1.

The implementation of waterproof enclosures for DSTV multi-switches will significantly reduce the risk of water-related damage and enhance the longevity of the DSTV infrastructure. Immediate approval and execution of this plan are recommended to prevent further damage and service disruptions.

#### 4. Identified Issues

The following issues were identified after the recent heavy rains and frequent complaints from tenants relating to loss of signal to the DSTV;s in the respective units:

Water infiltration has resulted in damage to DSTV switches, rendering the switches inoperable and unsafe.

- The water damage was particularly prevalent in Block R, Ground Floor, and Second Floor; however, further inspections have indicated similar concerns in other blocks.
- The absence of protective waterproof enclosures has left the switches vulnerable to moisture and rain exposure.
- The initial project design did not include provisions for the installation of DSTV multi-switches.

#### 5. Proposed Solution

To mitigate the risks associated with water damage, the following proactive measures are proposed:


- Acquisition and of waterproof enclosures rated IP67 or higher to ensure adequate protection against moisture and rain exposure to all blocks on phase 1;
- Procurement of DSTV multi-switches to maintain an inventory for immediate replacements, thereby preventing service disruptions;
- Installation of waterproof enclosures by the in-house maintenance team to ensure proper implementation;
- Regular inspections and quality assurance checks post-installation to verify the effectiveness and durability of the enclosures.
- Establishment of a preventive maintenance schedule to proactively monitor and address potential issues.

#### 7. Action Required

- Approval for the procurement of waterproof enclosures and DSTV multi-switches.
- Review of this report and provision of feedback or authorization to proceed with the proposed implementation plan.
- Establishment of an ongoing monitoring and preventive maintenance strategy to ensure continued protection and reliability of the DSTV infrastructure.

    - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
    - (e) forward the matter for criminal prosecution, if deemed necessary.
